- (iv)Local levies will also attract 2% of commission if not deposited prior to Agent account as in 7.0 below.
- (v)Any other charges to be communicated to the client.

7.0 LOCAL LEVIES:

(i)TRA taxes- after the assessment the client/consignee may deposit the amount with the Agency account or may pay direct to TRA and submit a receipt to the Agency.

(ii)Shipping lines charges through (TCTS) Tanzania International Container Terminal Services and (TRA)Tanzania Ports Authority – after the assessment the client/consignee may deposit the amount with the Agency bank account and submit a receipt to the Agency or pay direct to the respective institution.

.o NTRODUCTION

Government Procurement Services Agency (GPSA) was estab lished under the Executive Agency Act No. 30 of 1997 (Re-2009) and came into force through Government Notice No. 235 of 7th December 2007 and the order was amended as per Government Notice No. 133 of 15th April 2012. The official inauguration of the Agency took place on 16th June 2008.

2. o REQUIREMENT OF THE LAW

Clearing and Forwarding is one of the functions that GPSA is required to provide to the procuring entities pursuant to regulation 130 (5) of the Public Procurement Regulations, Government Notice No. 446 of 2013.

Government Clearing and Forwarding Agent as one of the sections of GPSA, is the one that provides clearing and forwarding services to the Ministries, Departments and Agencies (MDAs), Local Government Authorities(L-GAs) and Public Institutions in a cost effective manner. It also arranges for imports and exports of government consignments and public officials' personal effects.

3.0 MAJOR ACTIVITIES PERFORMED

The major activities carried out includes:-

- Clearing and Forwarding of imports and exports
- Advisory services to importers and exporters on the best way of handling imported and exported goods.



4.0 CONDITIONS FOR LOCAL CARGO (IMPORTS)

An importer of government consignment is required to submit to the Agency the following documents:

- i. Authorization letter from the importer
- ii. Bill of Lading/Airway Bill
- iii. Final Commercial invoice
- iv. Certificate of Origin
- v. Packing List
- vi. Copy of Tax Identification Number (TIN) certificate vii. Export Certificate and related local permits required
 - e.g Tanzania Medicines and Medical Devices Authority (TMDA), Government Chemist Laboratory Authority (GCLA) permit, Tanzania Bureau of Standards (TBS), Tropical Pesticides Research Institute (TPRI) etc.
- viii. Pre-shipment Verification of Conformity to Standards (P.V.O.C)

ix.VAT exemption if any.

Note that if these documents are submitted on time that is atleast two(2) and atleast seven (7) working days for airport and sea port consignment respectively, before the consignment arrival date, Government Clearing and Forwarding Agent may clear the consignment within three(3) and within seven (7) days to clear the consignment from the airport and sea port respectively. However nature of the consignment may delay the process. Nonetheless for emergency consignment through the airport may be cleared within one day.

5.0 TARIFFS GUIDE

The guide is prepared to fill the vacuum that existed between the Agent's clients on understanding the competitive rates that Government Clearing and Forwarding Agent charges on providing the clearing and forwarding services on local cargo imported and exported. This guide provides a basic understanding of our pricing standard and thus enhances simplicity, transparency and accountability on client and Agent staff side on its expedition.
